Once this time period has expired, we will delete your data by deleting your information from Bookwhen booking site and from our google forms repository. Please note by default Bookwhen booking system will hold your Data up to 12 months after your last booking.

### What are your data protection rights?

East London JKA Karate Club would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

**The right to access** – You have the right to request East London JKA Karate Club for copies of your personal data. We may charge you a small fee for this service.

**The right to rectification** – You have the right to request that East London JKA Karate Club correct any information you believe is inaccurate. You also have the right to request East London JKA Karate Club to complete the information you believe is incomplete.

**The right to erasure** – You have the right to request that East London JKA Karate Club erase your personal data, under certain conditions.

**The right to restrict processing** – You have the right to request that East London JKA Karate Club restrict the processing of your personal data, under certain conditions.

**The right to object to processing** – You have the right to object to East London JKA Karate Club 's processing of your personal data, under certain conditions.

**The right to data portability** – You have the right to request that East London JKA Karate Club transfer the data that we have collected to another organization, or directly to you, under certain conditions.
